PROJECT OUTLINE

1.0 INTRODUCTION

The Helion Street Definition and Naming Project will operate under a contract from the Republic of Anthelia Executive Council and will involve three phases:

- Phase One: Definitions & Classifications;
- Phase Two: Thoroughfare Identification; and
- Phase Three: Mapping.

Each phase will be completed by an agreed deadline (see Figure 1.1). Completion prior to the agreed deadline will elicit a per-day bonus payment from the Republic of Anthelia Executive Council to Montin Engineering Consultants (Gotz) Limited; late completions will be penalized through remittance of an agreed per-day fee to the Executive Council from Montin Engineering Consultants. Full legal obligations between the two parties will be defined in a contract separate from this document.

2.0 PROJECT PHASES

2.1 DEFINITIONS & CLASSIFICATIONS

The first phase of the Helion Street Definition and Naming Project will involve consultations between the Republic of Anthelia Executive Council and Montin Engineering Consultants (Gotz) Limited to determine various parameters for the project. Among these parameters are:

- Preferred thoroughfare designations (e.g. road, drive, boulevard, etc.);
- Parameters for potential street names (e.g. names of Anthelian citizens, cities, cultural icons, Micras micronations, or traditional; all being applied as street names);
- Development of an initial short list of potential street names by Montin Engineering Consultants (Gotz) Limited;
- Public consultations, conducted via a representative of the Anthelian micronation, at a location within Anthelia, to be determined, to gauge reaction to the short list; and
- Submission of final list of potential street names by Montin Engineering Consultants (Gotz) Limited and close-out of Phase One.

The final list of potential street names submitted will not assign thoroughfare designations. These designations will be assigned to each individual name during the secondary and tertiary phases as names are allotted to the thoroughfares.

The public consultation activity is expected to be the most difficult of the five due to the current low-levels of citizen participation being experienced throughout micronationalism. Ensuring that the Anthelian public is made fully aware of the consultation, upon its confirmed commencement date, and that the public is encouraged to participate in the hearings, is the sole responsibility of the Republic of Anthelia Executive Council through its assigned representative for the project.

2.2 THOROUGHFARE IDENTIFICATION

The second phase of the Helion Street Definition and Naming Project will identify thoroughfares in Helion and assign a name for each thoroughfare from the final list obtained through phase one. The thoroughfares will be identified as either major or minor in nature. Major thoroughfares will be the first named; minor thoroughfares will be named last.

Thoroughfares will be identified utilizing two key pieces of information:

- Coordinates of beginning, and end, of thoroughfare; and
- Direction of flow of thoroughfare between said coordinates.

The map of the city of Helion, as published by the Republic of Anthelia Executive Council in February 2006, will be used as the basis for the determination of coordinates and directions. Coordinates will be relative to this map only (i.e. local), and not to the global coordinate grid utilized by the Micronational Cartography Society.

Names on the final list from phase one considered to be of national importance will be assigned first to major thoroughfares, second to minor thoroughfares, where possible.

This phase will also involve the designation of numerical addresses to describe each building within the boundaries of Helion, as shown on the February 2006 map, in relation to the thoroughfare it borders upon.

The application of thoroughfare names has been set aside until 16 July 2006 (tentatively) for commencement to permit the confirmation of the final list from phase one by the Republic of Antheia Executive Council.

2.3 MAPPING

The final phase of the Helion Street Definition and Naming project will be the most intensive phase. Maps will be produced to show the thoroughfares and designated address numbers from phase two. One map each will be produced for:

- Showing both the major and minor thoroughfares of Helion together;
- Showing the major thoroughfares of Helion; and
- Showing the minor thoroughfares of Helion;

Furthermore, area maps will be produced to show the relation of numerical addresses to the thoroughfares. Upwards of ten area maps will be produced, with the final number dependent on the identification of major thoroughfares. These major thoroughfares will, in many cases, serve as area boundaries within the city limits of Helion for the purposes of this project. Other boundaries may be utilized to maximize the efficiency and presentation of the area mapping activity.

Montin Engineering Consultants (Gotz) Ltd will contract-out the development of some area maps to maximize the efficiency of this phase of the project. The contract will go to an Antheia-based company to be chosen following the completion of necessary tendering, and regulatory, procedures. The value of this contract will be in relation to the value of the project and will provide a major economic spin-off to Antheian industry. The definition of the contract parameters will be released at the appropriate time.
