

**TREATY OF MUTUAL RECOGNITION
BETWEEN THE ROYAL KINGDOM OF GOTZBORG AND
THE SOLOMONIC EMPIRE OF ATTERA**

Article 1. The Solomonomic Empire of Attera and the Royal Kingdom of Gotzborg express the desire to enter into an agreement that will adhere to the following: Both micronations hereby recognize the sovereignty of each party, and its supremacy within its territory. Both parties recognize the right and rule of each other's sovereigns within the territories of the other. Each party may send diplomatic missions to represent them, protect their interests, and foster closer relations between both micronations.

Article 2. For simplicity, both the Solomonomic Empire of Attera and the Royal Kingdom of Gotzborg shall be considered as "Contracting Nations" for the duration of this treaty. The Contracting Nations agree not to participate in any act that may damage, impair, or otherwise be construed as an act of war with the other Contracting Nation.

Article 3. The Solomonomic Empire of Attera and the Royal Kingdom of Gotzborg pledge amity and cooperative spirit between their respective governments. To continue these good relations, the citizens of both nations will be allowed free passage and use of each nation's forums, with the exception of sensitive links that are off limits.

Article 4. With the agreement of the Solomonomic Empire of Attera and the Royal Kingdom of Gotzborg, and until such time either government declares the contrary, both shall provide aid in the form of, exchange of ideas, advice and technical assistance for website maintenance. This exchange in aid, shall also extend to issues of activity within the forum of each nation, should it be requested by the sovereign of the micronation in need.

Article 5. All diplomatic emissaries shall be exempt from local regulations of the Contracting Nation and shall exercise diplomatic immunity. The receiving Nation may, at any time, declare such emissaries persona non grata, and deported forthwith with notice to the sending Nation. Diplomatic activity shall be governed by the provisions of the Vienna Convention.

Article 6. The diplomats of both Contracting Nations may, with the prior agreement of the other Nation, represent their Nations in other diplomatic Missions to Nations or Institutions.

Article 7. Amendments to this agreement shall be recognized only upon written agreement of the premier contracting authorities, or the successors of the former, of both Contracting Nations.

Article 8. The Solomonomic Empire of Attera, in its continued neutrality towards all governments, may not enter into any military agreement with any other micronation for an indefinite period of time. Yet, to reflect the status of valued friend, close relationship and respect for the Royal Kingdom of Gotzborg, the Atteran Imperial Government will place the status of "Most Favored Nation" upon the Royal Kingdom of Gotzborg. This status may be conferred or revoked at any time and for any reason, based on Imperial Edict, by His Serene Imperial Highness, the Emperor of the Atterans, who will receive notification that a majority of the members of the Atteran Yezawd Derg (Parliament), requests a change in status, or desires to place such status upon another micronation. Should a change in status occur, the Emperor of the Atterans must notify the former "Most Favored Nation" of the change of status and the reason for the change, in a timely manner. This period of time shall be no greater than a one-month period.

Article 9. This agreement shall be considered as law in both Contracting Nations in accordance with their internal legal procedure, and takes effect after satisfactory resolution of the foregoing sentence of this article, and the joint promulgation of the Contracting Nations of this agreement.
