About the Recovered Salary Payment

Of the two March 2006 salaries distributed, the first payments, authorized by RBC Chief Officer Steven DeBlood, will be recovered. This is because the second set of payments were calculated on an "as-owed per day" basis, whereas the first set of payment were, in some cases, higher than what the civil servant was entitled to receive based on their individual terms of employment. If a listed employee did not receive the first March salary payment, his/her second payment will not be affected.
