i. SUMMARY

During the latter part of April and the month of May of this year, 2006, the first-ever national census of the Gotzborg population was conducted under the auspices of the Ministry of Communications and Information. The goal of this census was to provide a general profile of the population's defining characteristics, as well as to gauge the population's opinions of issues of importance to the Royal Government.

The national census was a resounding success with 56% (14 out of 25) of the registered population of Gotzborg submitting a completed questionnaire. It is important to note also that the actual response rate is much higher as the 25 figure includes those citizens officially classified by the Royal Government as inactive. Some citizens who are classified as inactive were also among those who submitted a completed questionnaire.

Data was collected on a range of issues characteristic of the population, from macronational education to intermicronational travel habits. These will be discussed in more depth in the next section of the report, with the full raw data available in the appendix to this report. Furthermore, the census officer has worked through individual questionnaires to identify a number of interesting figures concerning the population, as will be outlined in section (iii) of this report. Finally, the fourth section of the report will offer reflections by the census officer on ways to improve the national census program for the next period.

ii. REVIEW OF RAW CENSUS DATA

General Trends

Utilizing the results of the census questionnaires, the following profile of the majority of the Gotzborg population can be constructed. All percentages used in this report from this point on, unless otherwise noted, are out of the total number of respondents (14) and not the total Gotzborg population.

Macronational Profile

Macronational Region of Origin:North America (64.3% of respondents)Religion:Christianity (57.1%)Not Specified/Non-practicing (28.6%)Macronational Education Level:Enrolled in/Completed Post-Secondary (64.3%)Age Group:Between 17 years old and 25 years old (50%) Less than 16 years old (7.1%)

It can be concluded from this information that Gotzborg's population is virtually split equally between those younger than 25 years old, and those older, and is geographically centered in North America. Furthermore, it is a largely Christian micronation, with a high-percentage of those who do not actively participate in religion (or care to specify a faith). Other religions are very much in a minority situation. The Gotzborg population is a highly educated group, with close to two-thirds currently enrolled in, or having completed, some form of post-secondary education (the vast majority being at the university level).

Gotzborg Information

Gotzborg's citizenry is actively involved in both the public and private sectors with their efforts aimed at improving their own micronational life, and that of the nation. The capital city of Lonenberg accounts for the most common location of residence for the population. The Gotzborg Housing Project, started in January 2006, remains weak in terms of participants, but seems to have a healthy start-up base at this time. Most citizens of Gotzborg who responded to the census have been members of the micronation for more than a year.

General Micronational Information

Intermicronational Visits (mode): (less than 3 other micronations – 42.9%) *Other micronational citizenships (mode):* (none) and (one) represent a combined (71.4%) Gotzborg's citizenry tend to not engage in a large amount of intermicronational travel, and very rarely hold a second micronational citizenship.

Gotzborg Government Policy Questions

Please note that the census asked only for reactions to three questions, and not for participants to list their ideas on how to tackle any shortcomings in measured responses. The Royal Government will, at a later date, consult the population on exact methods to improve desirable areas of policy.

The Royal Government makes an effort to inform citizens about employment opportunities within it: Yes (71.4%)

Top area in which more development is desired: Economy (50%) Areas in which no further development is seen as necessary (0% response): policing, immigration and human resources, health and environment.

Is the Chamber of Deputies representing the population adequately? Yes (57.1%)

Why are the unemployed living as such? No Clear List of Opportunities (66.7%)

iii. DATA RELATIONSHIPS

iv. METHODS TO IMPROVE UPON FOR 2007

The census officer is largely satisfied with how the 2006 national census was conducted. The primary method for improvement for the next census questionnaire is to increase the number of government policy questions. Asking citizens who are enrolled in, or completed, a post-secondary education program their professional fields would also permit a more accurate picture of the skills available from the citizenry. It would also be interesting to determine if Gotzborg was the first micronation of the respondent in future questionnaires, as well as is Gotzborg is the respondent's primary micronational focus.

Technically, this census did have some trouble distributing questionnaires to some registered citizens due to email problems on the recipient's end. An investigation of this yielded that the affected citizens were officially classified as inactive; therefore, their emails were likely closed-down. All the same, it should be a priority of the Royal Government to ensure that all emails of citizens are confirmed on a regular basis as the census officer was required to work with old email directories available from the Ministry of Communications and Information.
